Nancy Bushika opened the meeting with the Pledge of Allegiance, welcomed everyone, and read a statement with procedural rules for the meeting. Additional correspondence was added to the agenda. There were no changes to its order.

HEARING OF VISITORS

Sally Bohl reported that yesterday's town tax sale went well. Two properties were sold and one Alpenwald property was acquired by the town. Someone contacted the attorney today and purchased the town's interest in the Alpenwald property.

MOTION by Mike Denault to accept the offer and sign the assignment transferring the town's interest to the new buyer. SECONDED by Kurt Gamari. All in favor. Motion APPROVED.

MINUTES

MOTION by Mike Denault to accept the regular meeting minutes of December 21, 2023 as written. SECONDED by Kurt Gamari. All in favor. Motion APPROVED.

SELECTBOARD ORDERS

The Selectboard reviewed and approved the following orders:

ROAD CONDITIONS

- 1. The road conditions have been muddy. Stone was added to Mill Road and upper County Road.
- 2. The plow on Dave Tatro's truck had a slow hydraulic leak this week. Dave Tatro replaced the part as soon as he noticed it. The Fire Department was dispatched and cleaned the area. It was only a small amount of fluid. Pam Tworig was grateful for our Fire Department and the job they do.
- 3. Dave Tatro looked into the sign mentioned by Pam Tworig at the last meeting. It is not regulatory and gives a false sense of security. Dave Tatro will not replace the sign and as he has the time, he will take the signs down.

RECYCLING

Dave Tatro reported that there is a large quantity of batteries at the recycling center. Customers will be asked to cover both ends with tape before disposal. Nancy Bushika felt the recycling monitors can tape the ends of the batteries a little each week.

EMERGENCY MANAGEMENT

The final draft of the Continuity of Operations Plan will be added as an appendix to the town's Local Emergency Management Plan.

FINANCE COMMITTEE

One candidate withdrew their offer to serve on the committee. No one else has come forward. There is only one volunteer which is not enough. No appointments were made.

FEMA BUYOUT

Mike Denault read the buy out papers and felt the board should look at them carefully. He is not comfortable signing them and is not sure the terms are in the best interests of the town. Pam Tworig felt the language is boilerplate. The board will gather their questions and invite a FEMA representative to an upcoming meeting to explain.

MINUTES

Nancy Bushika would like to see the minutes shortened. Zoom and televising the meetings were discussed. A local resident will be approached to consider livestream or recording of the meetings.

TOWN LAND PURCHASE

The board discussed purchasing a parcel in town to move the highway garage away from the river. MOTION by Mike Denault to use the town ARPA funds to place a bid of \$20,000.00 to purchase the land. SECONDED by Kurt Gamari. After discussion, Mike Denault amended his motion. MOTION by Mike Denault to use the town ARPA funds to place a bid of \$25,000.00 to purchase the land. SECONDED by Kurt Gamari.

Nancy Bushika has prepared the town report for the past several years. She asked board members to help by preparing their own drafts for the next meeting.
