TOWN OF STAMFORD SELECTBOARD MEETING

February 1, 2024 (UNAPPROVED)

Nancy Bushika opened the meeting with the Pledge of Allegiance, welcomed everyone, and read a statement with procedural rules for the meeting. Additional correspondence, and information regarding a legislative bill were added to the agenda. There were no changes to its order.

HEARING OF VISITORS

- 1. Mary Lou Wright spoke on behalf of the Stamford Community Church concerning a disturbance that took place at their service last week. The lack of police presence and police response time was discussed. The school and town office have safety measures in place.
- 2. Laura Champagne asked about Stamford's leash law and will talk to the Dog Officer concerning a dog on her property.
- 3. Laura Champagne noted that Mill Road has many potholes and the gravel on Brown Brook Road is diminishing.

FEMA BUYOUT PROGRAM

Dave Saldo noted that the board decided to move forward with the program and feels it should be brought to the tax payers since it will affect the whole tax base. The amount of potential houses in the flood zone and river corridor was reviewed. Dave Saldo was a part of the adoption of the flood hazard regulations and he pointed out sections and noted other resources. Pam Tworig brought in a picture showing how much the river behind her house has moved over the years. The board discussed the workshop they attended earlier and although Vermont Emergency Management can oversee the buyout program, there will be a lot of administrative responsibility the town will have to undertake. Deb Burchard said it is a lengthy and stressful process that she wishes she didn't have to go through.

SELECTBOARD REPORT FOR TOWN REPORT

The Selectboard reviewed the final draft.

MOTION by Mike Denault to accept the Selectboard Report for inclusion in the Town Report as presented. SECONDED by Marie Kelly-Whitney. All in favor. Motion APPROVED.

CERTIFICATE OF HIGHWAY MILES

The board reviewed the Certificate of Highway Miles. There have been no changes since last year. MOTION by Mike Denault to accept the Certificate of Highway Miles. SECONDED by Marie Kelly-Whitney. All in favor. Motion APPROVED.

MUNICIPAL ENERGY RESILIENCE PROGRAM

Lori Shepard applied for a grant for an energy assessment of the town garage. There should be no cost to the town.

MOTION by Pam Tworig to sign the Memorandum of Agreement for the grant. SECONDED by Marie Kelly-Whitney. All in favor. Motion APPROVED.

2024 GRANTS IN AID

The Bennington County Regional Commission would like to assist the town with the upcoming Grants in Aid project and has submitted a Scope of Work to be signed by the board.

MOTION by Mike Denault to accept and sign the Scope of Work. SECONDED by Kurt Gamari. All in favor. Motion APPROVED.

HAULER REGISTRATION RENEWALS

The Selectboard reviewed and signed letters sending the hauler registration forms to local recycling and trash haulers.

NEW STAMFORD SIGN

1. The Selectboard sent a letter to the Zoning Board of Adjustment requesting an extension of the sign removal date to allow the board to pursue an appeal through the State Environmental Court.

There is a filing fee of \$295.00. The board also considered requesting a waiver through the Zoning Board of Adjustment, which is different than the variance previously requested. Mike Denault did not want to spend any more money.

MOTION by Pam Tworig to file the appeal with the Judicial Bureau Environmental Court appealing the decision of the Zoning Board of Adjustment and to pay the filing fee with the remaining Community Projects Committee grant money. SECONDED by Marie Kelly-Whitney. All in favor. Motion APPROVED.

- 2. Dave Saldo asked if anyone was pursuing a permit from the state for the sign. It was explained that the sign is too close to the road because of the town setbacks, but it is not in the highway right-of-way.
- 3. Pam Tworig noted the numerous times the Community Projects Committee met to discuss the sign and how it was staked out for weeks on the front lawn and no one said anything.
- 4. The validity of the Zoning Board's removal date decision was questioned again. Dave Saldo said the Zoning Board is a quasi-judicial board and it did not have to be done in an open meeting.
- 5. The Zoning Board of Adjustment will hold a meeting on February 20, 2024 to discuss the Selectboard's request for an extension of the sign removal date.

LEGISLATIVE BILL H-629

The legislature is discussing a bill that will have great negative impacts on municipal tax auctions. Attorney Kevin O'Toole is testifying against the bill and has asked the town to write a letter also. MOTION by Nancy Bushika to send a letter from the town against the bill. SECONDED by Marie Kelly-Whitney. All in favor. Motion APPROVED.

MOTION by Mike Denault to adjourn. SECONDED by Marie Kelly-Whitney. All in favor. Motion APPROVED. The meeting ended at 7:45 p.m.
